1. Tests T.1 to T.5 shall be conducted in sequence on the same battery. Tests T.6 and T.8 shall be conducted using not otherwise tested cells. Test T.7 may be conducted using undamaged batteries previously used in Tests T.1 to T.5 for purposes of testing on cycled batteries. 测试T 1-T 5须按顺序依次在同一组由独上进行。T 6和T 8须用全新的电芯进行测试。T 7 可以用之前T
